- There is an Environmental Scan (ES) being put on by CANA (Canadian Assembly of NA) to assess the effectiveness of the services it offers. This ES gives CANA input from the fellowship so they can make decisions for strategic planning for the next couple of years. This ES needs to be completed and returned no later than Aug 1st to prepare for the live meeting of CANA that is held around the time of the Canadian Convention. It's important that they have input from Atlantic Canada so there will be a 90-minute Environmental Scan Workshop hosted by the RD, Carl (Regional Delegate) Sunday, July 14th at 10:00 a.m. Zoom ID: 937 9880 0030 PW: NAservice All are welcome!
- The recently launched billboard campaign allows addicts in Halifax, NS and St. John's, NL to see the fruits of a CANA PR campaign that was launched in Quebec.
- NA literature is constantly being developed in indigenous languages as members fluent in such languages take on the role of translators in aid of carrying the message.
- The World Convention will be in Washington, DC this year. Check the CARNA website for more information. It's sure to be an experience you will always remember.
- Both contributions and literature sales have been down at the world level since the COVID Pandemic although there is now evidence that both are picking up.
- All interested members can visit the CANA-ACNA website (canaacna.org) for opportunities to join committees and become part of the larger service structure.
