Proposal to buy a printer for Area use. We discussed existing obstacles to putting this into practice:

- Taxes & Eco fees apply to printer and to any ink or toner purchases.
- 2. What type of printer Laser or inkjet? Colour or B&W? Can it automatically double-side? Would it do paper only or can it print cardstock?
- Who pays for & ensures there's enough ink or toner & paper on hand? How do we track ink & paper usage.
- 4. Where will it be stored? What is the ease of access to that storage for anyone wanting to use the printer? Security of the printer & storage facility needs to be considered. How would we track the printer's whereabouts? Is there a signing out & return policy?
- 5. What about reimbursement to Area for damage or replacement?
- What if more than one committee needs to use it at the same time? This would happen more so as we near the weekend of Area.
- There are other costs not associated with the purchase, such as gas, travel time, and extra coordination & planning required for equitable use by six committees.

Our consensus on buying a printer for Area use is that more info is required before an informed decision could be made. We ask that, as written, the proposal be withdrawn until such time as the requisite info is provided. If not withdrawn, our consensus is not to support the purchase.
